Achievements / What we are (reasonably!) happy about

- 1. As an organization active since 1995 with a clear focus on the domain of work.
- 2. Wide range of support with no critical dependence on a single source.
- 3. Comprehensive approach to work on sustainable agriculture from seeds to marketplace.

Evolved from documentation and research and progressed to scaling up of activities and market linkages.

- 4. A large range of educational and training materials in Tamil, English and various other languages which serve as a comprehensive and excellent resource for many farmers and groups.
- 5. Good track record with respect to compliance legal and regulatory matters, income tax, FCRA, etc.

Failures and Shortfalls

- 1. No long term or effective linkages with universities and research institutions failed attempt to
 - "Mainstream" courses on sustainable agriculture, poor record of "Collaboration in

research"...However, we have friends and goodwill which has been of some help.

- 2. No effective or powerful linkages with government programs or schemes linkages in "Fits and Starts", lack of continuity due to various reasons.
- 3. Unable to continue effective funding relationships with central or state government agencies had linkages for over 25 years and then decided to tone down to minimum interaction.
- 4. Dependence on foreign funding sources continues to be important while this has not been our major source of funding overall and through the years.

Scaling up our activities - changing strategy (changing goal post?)

1. Our initial thinking was that we will - "Demonstrate sustainable agriculture based on

traditional knowledge" as a pilot effort in a limited area with donations/grants and this may be

used to make a case for scaling up such efforts through the initiation of a dialogue/ discussion

with larger administration of agriculture in the country at large.

- 2. This thinking has now been abandoned or definitely not "At the forefront" of our efforts.
- 3. Currently, our efforts are more towards trying to go to scale through links with the

marketplace.

03 Efforts in Progress



Efforts in progress: Promotion of multiple forms of institutions

1. We have recognized that for achieving various of our objectives we may require not only a - "Nonprofit organization"

such as CIKS but also profit-making entities (such as company)

- 2. About 10 years back we supported the formation of a private limited company with the idea that it could be a "Social enterprise"
- 3. Around the same time, the government also launched efforts to promote "Producer companies" which are in the nature of a hybrid while their institutional form is that of a company, by definition they have both business and social objectives. CIKS is continuing to work with a limited number of such PCs.

Is it possible to work out a suitable partnership/synergy between these three organizational forms - Not-for-profit trust,

social enterprise and producer companies? As of now, this is an effort which is - "Still in progress" - there are challenges, but

it shows promise

Efforts in progress: Networks and partnerships

- 1. Initial efforts were short term and limited in scope.
- 2. Recent efforts at networking with various other farmers groups and FPCs to scale up our work

within Tamil Nadu state - ongoing and promising.

3. Partnerships with other organizations with whom we see possible synergy in various aspects of

sustainable agriculture and natural resource management - initiated and promising.

Future Challenges and Opportunities



Challenges

- 1. Challenges faced by the agriculture sector are at multiple levels -
- Severe erosion of the resource base soil fertility, water, biodiversity...
- Overall low value is assigned to agriculture in comparison with urban/industrial sectors.
- Emerging serious threats such as Human-animal conflict with implications for agriculture.
- 2. Reworking relationships with corporates in the light of new and changing regulatory requirements. Funds are

available but there is a push towards - "Measurement and quantification" of results and output. This leads to

some challenges such as - lack of support for long term programs and/or building of human resources.

3. There is also a trend towards prioritizing activities that are amenable to measurement and quantification. This

has also resulted in a new set of - "Intermediaries of the CSR world" who have the technology and language for

proposal writing, measurement and quantification, reporting, etc.

Challenges and Opportunities

- 4. Nurturing varied skills required by the organization field work, communication, reporting and raising resources.
- 5. Balancing the spirit and enthusiasm of volunteer effort and public work with technical and professional skills required for quality work in agriculture.
- 6. Exploring institutional models for generating resources based on our own activities within the framework of the law.
- 7. Concerns about problems of climate change and the emerging "Ecological crisis" have created an opportunity that is favourable for sustainable agriculture approaches.

A Few Things We Want to Achieve

- 1. Scale up cultivation of TRVs through partnerships and linkages.
- 2. Work on post harvest processing and get at least 50 more traditional rice varieties to the consumer.
- 3. Evolve robust business models for input units such as neem seed powder, neem soap, vermicompost.
- 4. Improvements on post harvest processing.
- 5. Small scale machinery for agriculture.
- 6. Extensive studies on nutritional and therapeutic properties of rices.
- 7. A facility in every district for region specific seed supply.
- 8. A museum/interpretation centre on rice.
